The auditor did provide a management letter regarding two minor issues that have already been addressed. He noted that we had excellent financial results which resulted from a decrease in operating expenses which he commended Dep ED Homefield and her staff for. He then introduced Frank Holman of Holman, Frenia, Allison, P.C.

Mr. Holman explained the single audit and stated that if the HA liquidated all liabilities today, there would still be over \$400K left. He commended Dep ED Homefield and ED

Dzema for a job well done.

Dep ED Homefield read the vacancy report for November. There is 1 vacancy at Ptak and there are 0 at JPM. There are 5 residents on the Ptak waiting list and 54 non-residents. There are 9 residents on the waiting list at JPM and 44 non-residents.

ED Dzema reported that the request for a smoking shelter is being looked into.

Capital Report – Ptak Towers; One of the two hot water heaters has a leak so we are entertaining proposals to replace both and hopefully will award a contract in the next few

weeks.

We did submit a 404 mitigation plan for supplemental funds (for generator) where 75% is possible from the State but we have not heard yet.

We did hire a structural engineering firm to perform a study of Ptak as we know there are some structural settlement issues.

The Ptak generator has been having exhaust problems. Our contractor has been out to do testing and installed a block heater which has alleviated a significant amount of the problem.

Capital Report – JPM; We also submitted a 404 mitigation plan for a generator and are awaiting a response.
