COMMITTEE REPORTS

Renee read the vacancy report for August. There was 1 vacancy at Ptak and 0 at JPM. There are 9 residents on the Ptak waiting list and 52 non-residents. There is 1 resident on the waiting list at JPM and 31 non-residents.

Comm Rugg – We had a tenant picnic, many contributed. For bingo I have been cooking as Barbara has been sick, she had a shunt put in her heart. This week we had 6 birthdays.

Comm Tkoch - I would like to thank Doug for painting the walls and for the new trim in the hallways. He did a great job.

Renee – regarding the furniture on the 5th floor, the order was not correct - they sent the wrong pieces. It will be a three seater and two additional chairs. The correct pieces are on their way.

OFFICERS & STAFF REPORTS

DOF Furlong gave update:

- There is going to be an Anniversary get together here on September 16th in the Community Room at 2:00pm for all the residents.
- Some good news, we have finally received approval from FEMA for the generator project at both Ptak and JPM. The total cost of the project is \$236,000; FEMA will pick up \$219,900 and the housing authority will be responsible for \$16,100.
- More good news is that we received our REAC scores from HUD, for our annual (every few years if we do well) property inspections. We received at 95 at Ptak and a 96 at JPM, excellent scores. I see a lot of housing authority in the state score's and these are great.
- We have provided a support letter to the NJ Institute for Disabilities we applied for a grant under the HUD ROSS program. They are putting in for a coordinator, if they receive funding the coordinator would provide services/referral assistance for our seniors and disabled here at Ptak as well as the disabled at JPM.
- The RAD (project based voucher) program received approval from HUD a few months back for both Ptak and JPM. Now we are in the process of converting over. HUD wants us to close by the middle of January, but they will probably grant extensions which

will be needed and take us into February/March. This program will allow us to do capital improvements. We will be required to have resident meetings talking about the conversions and how it will impact you. For the residents it will be a pretty seamless transition. We are required to have monthly calls with HUD to discuss progress. Next we will have to sit down with the borough and make sure they are on board with the program. In addition we may also have to work out a new payment in lieu of tax agreement.

- ED Dzema has a conflict with the September 22 meeting and would like to reschedule, is the board available – September 14, September 21 or September 30? No 30th Bingo – let's move it back a night to September 21.

Donna Torres, apt. 308 – I would just like to say thank you for having out windows washed. On Resolution FY16-002, what is it actually for? **Renee** – it is for upgrading the camera/security system. Replacing existing and adding additional security cameras both here at Ptak and at JPM.

Ida Tkock, apt. 408 – tenants are complaining to me, we need the carpets cleaned in the hallways again, there are some large spots. **Renee** – We did have all the carpets cleaned about a year ago, we are looking into this issue.

Ronnie Staehle, apt. 217 – I have a question pertaining to the lease. How many nights per year are we allowed to have overnight guests? **Renee** – 30 overnight guest are allowed per year. A guest sheet must be completed and returned to the office for each guest stay.
