ED Dzema - T-Mobile is here to speak as there is an interest in placing antennas on our building for enhanced cellular service. They would rent space on the roof and pay for utilities. T-Mobile will make their presentation to both you the tenants, and the board members. Any questions may be asked and the board members will vote if we will move forward with the potential rental. Douglas Sabey, Construction Inspector – I have been involved in several of these installations. We have 4 carriers in Perth Amboy. There are no costs to the housing authority. There is virtually no impact on the tenants or the facility. Matt, T-Mobile - there would be 3 antennas/arrays to enhance the service to the area with 911 capabilities. Approximately 6-10 feet high. These will be mounted to the roof of the building. Joe, RF Engineer - the antennas will receive and send transmissions to cell phones. Regarding safety there are standards. There are no issues with these at all. Comm Francy - What if we have to make a repair on the roof? What if it was due to their equipment? D. Sabey - They would have to shut down the system and we would go up and make the repair. Matt - If damage was due to our equipment we would take care of the repair. Tenant – Would there be a generator up there? Matt – There would be a small generator installed on the ground. It would be for backup power when there is a power outage, specifically for 911 usage. Tenant - Will all the residents get free phones/service? Matt - Unfortunately it doesn't work that way which is why we are paving rent to the property. Doug Sabey - the money that comes in to the building from the antennas will be used for the benefit of the residents.

Comm Goddard – We have a land use board, have you been in contact with them?

Matt – If /and once the agreement is in place we will be reaching out and filling out any applications and getting any permits that are required to get this set up and running. The process takes a while. T-Mobile already has coverage in the area, this site is for enhancement. Tenant – I have Metro cell phone. After 10 minutes on a call in this building I get a message out of network. Will this improve my phone? Doug Sabey – there are different carriers so it is hard to say. It is very possible after we have one carrier we may attract another lease.
