<u>September Vacancy Report</u>: Ptak and JPM have 0 vacancies. Ptak has 9 residents and 114 non-residents on the waiting list. JPM has 4 residents and 56 non-residents on the waiting list.

# Capital Report -

<u>Ptak</u> - The generator project is completed. We are preparing the documentation to present to the state to get reimbursement.

- We expect the UST project to begin in October. The contractor has applied for the permits. This is for removing the tank in the back parking lot behind the boiler room.
- The canopy over the rear patio needs to be replaced. The RFP is out and the canopy will be replaced in the next couple of months.
- We are still waiting for the repair person to fix the minor leak on the roof. JPM The generator project same as Ptak.
- -As we had indicated we had a radio system installed for the fire alarm system. This is an upgrade from the copper wiring system that was in place.

RAD Update – We have been receiving inquiries from the FHLB. They are fine tuning our application, which is good news. The application fee that the board approved last month has been submitted to Investors Bank. We are borrowing for capital improvements for our buildings, which HUD is requiring. We did get an approved extension until the end of the year, December 2017; to submit all our budgetary work for the RAD Program on the capital projects.

**Budget** – was just returned to us, approved by the DCA.

**Audit** – field work was completed on Friday. I met with them on Friday for a close out meeting; so far there are no red flags.

Cable television service—we are having no success. Renee – Tom has reached out to Comcast once again — with no success. VChair—we need to look into other alternatives, maybe the digital antennas. We need to set a goal with deadlines. Now that I know this avenue is closed I am going to look at other avenues.

No Smoking Notice to the Tenants - <u>AttyBonello</u> - The Notice informs the tenants the Authority will enforce the current restrictions in your lease prohibiting smoking anywhere on the Authority unless designated. This is now required by HUD, as they passed regulations prohibiting smoking at any public housing authority. The regulations require the management of the Highlands Housing Authority to strictly enforce no smoking in the units or on the property. If a tenant is caught smoking, legal action will be taken.
