CORRESPONDENCE

ED Dzema - There are 2 lists that have been prepared on a monthly basis. The COVID- 19 Distribution list has the items yellowed out that have taken place since the last meeting. The United Methodist Church has been consistent delivering grocery bags weekly and our staff has been involved by delivering the bags to the tenant's doors and even more so recently by going to the church to pick up the bags and then deliver them to the tenants. Today they are picking up a full Thanksgiving dinner for the JPM tenants. Last week Katz's delivered a pre-Thanksgiving dinner to tenants at the building. The 2nd list is the Notices that have gone out to the tenants which include one for the flu clinic, the United Methodist Church Thanksgiving dinner just mentioned, as well as the Blessing Bag Brigade/Proving Ground Thanksgiving dinner, which is also being delivered to the building and staff will deliver to the tenants doors. The community support in Highlands is second to none!

COMMITTEE REPORTS

Comm Williams - I did get an email from Dan the principal at Highlands Elementary School. He knows we are not meeting and they are not able to bring people in; he will let me know when the restrictions are lifted.

Comm Tkoch - everyone is wearing a mask, everything is pretty smooth.

Renee - October Report: 0 vacancies at Ptak and JPM. At Ptak: 9 residents and 64 non-residents on the waiting list. At JPM: 1 resident and 22 non-residents on the waiting list.

OFFICERS & STAFF REPORTS

ED Dzema - Status Quo with the staff and COVID, they are coping and handling it; hopefully they will not let their guard down because it has been going on so long and it is ramping up. As it pertains to our Board the Governor has reinforced the fact allowing the municipalities the ability to meet. Perth Amboy is walking away from any public meetings, it may be because of the uptick and they are sticking with Zoom meetings. With the going on in the state, the popular belief is the Governor is pushing to get us beyond the Holidays. The vaccine sounds very promising, there are three of them out there now; 2 of them with 90% + probability. It sounds like healthcare workers will be the first in line with those most susceptible to follow. It sounds like the mainstream will not get the vaccine until April/May. Our telephone entry system, the KERI system, had become antiquated and needed to be replaced. We bid out the job and awarded the contract. The system went down before the company came down to do the replacement. The existing laundry vendor is looking for right of first refusal, not removing their equipment to allow the new company that won the bid, SEBCO to come in. ATTY Bonello - per NJ public contract act, voids the right of first refusal. My recommendation is to take them out per my letter for them to remove equipment by December 4. **ED Dzema** - Becky is not on the call today as she has a conflict with work. Does the board feel we should reconsider the time of the December meeting, back to 7:00pm? The majority agrees it should be changed back to 7:00pm for the December 22 meeting.
