We will be asking the board to consider action of notification of the borough council that she has stepped away. Capitol Items: JPM - We are putting 10 sets of new windows in. Joe and John will access the worst windows at JPM based on water filtration and air issues. This will put us in a really good spot at JPM with windows. We are doing some concrete repair work with broken pieces of sidewalk that need to be taken care of. We are doing 2 more porch replacements, B1 and B6. We have estimates on the bid, we will see where the bids come in and whether we are awarding 1 or 2 or none; bids are due in October 9. Ptak - we are replacing our phone landline; we are upgrading to an antenna system. We want to start investing a little bit of money into the elevators slowly. We did have an engineer come out and access them. We should replace the multi and traveler communication cables. From the boiler plant here we are involved in a water treatment program, which we have been involved in for some time now. We have to treat our water to fight corrosion of the boilers, the chemicals fight off the corrosion. The water is fine to drink, it is bad for the boilers, this is about a \$3000 job.
