COMMITTEE REPORTS

Comm Rugg – Barbara Hartsgrove prepared for the Christmas bingo. Vickie Marks organized the New Year's Day Bingo. I ordered Pizza for the week after. There are lights out on the bingo board. A representative from Beacon of Life has been attending Bingo and giving away prizes. Beacon of Life had a bus trip to their facility, a lot of tenants signed up for the trip, although they did not show up for it.

Renee read the vacancy report for January. There are 0 vacancies at Ptak and JPM. There are 5 residents on the Ptak waiting list and 95 non-residents. There are 4 residents on the JPM waiting list and 50 non-residents.

OFFICERS & STAFF REPORTS

ED Dzema –

- -Fire Safety training took place Dec. 5. We thank Charlie Wells, Deputy Fire Marshall, Highlands Fire Department; he came out to give the fire safety presentation and an overview on how to use the new fire extinguishers which have been installed in all apartments.
- -Comcast/cable update. We are told there will not be any FIOS in the area. **Renee** Tom has made many calls to Comcast and is getting the run around. We are waiting to hear if back if they will offer a discount/how much of a discount/options available, if all tenants sign on individually (residential department); and what services/discount is available, if management signs a building contract (commercial department).
- -RAD Program Update: PNC has pulled back their proposal, we do not have an investor at this time. The capital improvements needs that we have to effectuate both here and at Jennie Parker cost money, so we need a loan. Federal Home Loan Bank will be an option for us, this is a grant not a loan. 4 % Tax credits are also an option. No matter what the funding source is, it will not affect the tenants residency.
- -A curb cut was requested for in front of the building. The borough has looked at this for us. The work to do this would be extensive as the street has to be milled and paved per requirements of the ADA. The estimated cost is \$30,000 plus. The borough will get back to us if they willing to pay for all or some of this; we do not have the money to do this.

- -JPM's generator is scheduled for the gas line and electric line hook ups the week of Jan. 23 and start up for the week of Jan. 30.
- -The HUD non-smoking policy is on hold due to the new administration taking over. They will be assessing what programs exist and which ones need to move forward.

<u>OLD BUSINESS</u> – Comm Williams - I had a conversation with Maureen Welch of the Highlands Arts Council regarding an Arts Program. **Renee** - I will follow up by contacting the borough and the Arts Council to see what has progressed.

NEW BUSINESS – None to report.
