ED Dzema gave results of our current financial status, reviewing the twelve months ended June 30, 2015; our reserve level has increased. A good outlook so far. The six month report ended December 31, 2015, revenue is down \$9000 due to HUD cut in subsidy from 89% to 87%. Again we do have a surplus, that is through 6 months; we will still have expenses to pay over the next 6 months. We should still have a nice surplus.

Susan Lenz and Mark Gioioso, RAD (Rental Assistance Demonstration) Financial Consultants reviewed the structuring of the low income tax credit program (getting tax credits) versus a getting a bank loan/mortgage for the authority. After this discussion a poll was taken and the general consensus of the board was to acquire a mortgage, rather than go with tax credits, to accompany the RAD conversion for the authority.

Thomas Furlong reviewed projected budget for 2017. We are not incorporating the RAD program into this budget as we do not know when it will close, you will have a revised budget when that does happen, this is still the public housing budget. The worksheet and budget line items were reviewed. The board gave approval to proceed with final budget at upcoming board meeting on March 22.
