AUDIT REPORT

ED Dzema introduced Brian Waldon, audit manager and Tyler Donnelly, field agent; from Holman Frenia Allison, our Auditors. Tonight we will have the board as the committee instead of breaking into the subcommittee. There were no findings and no management letter. There were some adjustments to our financial statement, we booked our unfunded pension liability, we just found out about that June, 30, 2015. We had excellent financial results. We always deal in percentages, the threshold for a HUD well run authority is at a 40% level, this year you are at 83% level. This is 23% higher than last year. Brian – the net pension liability being shown on the financial statement is a statewide implantation. This is called GASB68. The liability with continue to adjust every year. This is not shown in the 83%. It will not affect anything the authority has done.
