### COMMITTEE REPORTS

August Vacancy Report: 0 vacancies at Ptak and JPM. 11 residents on the Ptak waiting list and 108 non-residents. 6 residents on the JPM waiting list and 55 non-residents.

Comm Rugg – we still have bingo, some drop out for the summer so we are expecting they will be back in the fall. We no longer have food.

Comm Williams – The oral history workshop went very well. We just had the second one and are having the third one in September –  $25^{\text{th}}$  at 10:00am. People share fun memories, we write, we talk, we laugh. It is a combination of the residents and people from town.

Comm Tkoch – we had our anniversary dinner in June, it was nice. I have mentioned this before, everyone should have a bath chair; it is real important. We would like flowers instead of vegetables in the pots out back next year.

## **OFFICERS & STAFF REPORTS**

### ED Dzema -

RAD Program – We will not be hearing back on the FHLB application which we submitted for more money, until November/December. We did accept financial proposals as additional cash is needed for the RAD program, for capital improvements. 13 proposals were sent out, we received response from only one – Investors Bank. Capital Report -

<u>Ptak</u> - The new generator is up and running and has a great deal of power. It goes on once a week for testing. We also have a new one up and running at JPM.

- UST project will be talked about when we get to resolutions.

- The canopy out on the rear patio needs to and will be replaced. We are accepting proposals for that now.

- We have a minor leak on the roof, the contractor is scheduled to come to repair it.

**JPM** – Fire alarms are in each of the three buildings and are independently monitored with three separate alarms. They are run by copper wiring which we are eliminating and moving to a radio system.

<u>Cable television service</u> – The VChair has been speaking about a digital antenna, Renee has been trying to reach the cable company to see if they will give us a discount. <u>Renee</u> – Tom had been trying to reach Comcast with no success. The mayor gave us a contact, Mr. Clifton at Comcast to direct our inquiry to. Tom has had no response from him. The mayor once again reached out to Mr. Clifton for us and Tom did hear back from him today. He was passing our information on to their business department for follow up. <u>VChair</u> – this is something we have to pursue, we have to keep on them and we should not take NO for an answer.

**Employee matter** – one of our employees, John Hemenway is going out on medical leave that will keep him away for a number of weeks. We have a part time maintenance

man from the Keansburg Housing Authority that we will bring on board to work half days to support Joe Cusumano.

<u>Carpets</u> – will be cleaned in the common areas, Wednesday and Thursday of this week. <u>Back Wall</u> – we have a proposal from Jim Kovic, for cleaning/painting the back wall that the board has not seen and we will discuss.
