On April 26 a number of us went and met with the Highlands Historical Society to share what the group was doing and to invite their members to join our group. Next year we will try to identify the parents with children at JPM and try to engage them to get involved with the calendar contest.

Comm Tkoch – some of the tenants want their thermostats checked in the living room as they say they are not working properly. We also need more chairs in the back yard. Saturday is the Memorial Day parade in town. After the parade Katz's is having a town wide picnic in their parking lot. On Sunday my son Mark is having a Memorial Day Party in the community room/back patio.

ED Dzema -

A RAD meeting took place on May 14. Both developments were invited. It was opened as a public meeting as four commissioners were in attendance. Attendance by the tenants was excellent. Bill Snyder, our consultant did a power point presentation. We walked through the entire process and spoke about the work items that are going to be corrected in the next number of months and/or years. We are projecting a closing in the middle of June, as our new fiscal year starts July 1.

FY18-022 – Resolution to approve the operating budget FY 2019.

ED Dzema – We will hear from our CFO Tom Furlong in a few minutes. Thank you to the finance committee that came out to meet prior to the RAD meeting to go discuss the upcoming budget. We would like to introduce it tonight. With the RAD conversion we do expect approximately an 18% up kick financially in terms of our cash flow. Our reserve is at 78%, HUD asks that you at least acquire a 40% reserve.

Comm Goddard – The Finance Committee met and strongly agrees that they need to recognize the members of staff for the job that they have been doing and have done, particularly as it pertains to RAD. The Finance Committee feels they wanted to show their appreciation with a more healthy increase - a typical increase would be 2% we strongly recommend the staff get a 3.5% increase this year.

Tom Furlong -5 or 6 years ago we were cutting because of the financial situation we were in. It has really turned around the last couple of years and we are going into the RAD program with a couple hundred thousand dollars in our bank account which is really nice and a lot has to do with the staff. In the budget there is a surplus of \$25,000 and we really think that putting a million dollars into both developments with the RAD program is really going to save us some money.

PUBLIC PORTION

Victoria Marks, apt. 311 – At the tenant RAD meeting, Mr. Snyder mentioned there may be a few tenants that have to pay 35% of their income for rent? ED Dzema – Two different issues. We believe we have one person that may have to pay an inflated rent based on their income, which is a private calculation and there is a 3 to 5 year period for that increase to occur. This is because ceiling/flat rents are going away. The 35% is a number that was thrown out by Ben Carson, Secretary of HUD. There has been no action taken by the senate or legislature for this increase. If this would happen it would affect everyone.

Jacqueline White, apt. 102 - I would like to know if I could have a copy of the board meeting minutes, I am losing my hearing? ED Dzema – the minutes from the board meetings are on our web site. You can use the computer right here in the community

room. If you can't use a computer you can go into the office and request them. Just submit a written request so we have it documented.

Larry Wallace, apt. 206 – Is there something called a tenant handbook? ED Dzema – I don't know of one.
