Would love to get this going. <u>ED</u> – she did call Renee and wanted to give us a per person cost. <u>VC</u> – I would like to ask what were the recommendations that the JIF inspector made for safety? <u>ED</u> - He spoke about a no smoking policy/HUD is considering new legislation banning smoking in all public buildings. We need to keep up JPM fire escape regulations. Recommended we keep snow logs, and keeping up to date with Joe's power industrial truck training. <u>VC</u> – The request I have is for someone to look at the back ramp. <u>RD</u> – It was inspected, no siting's. <u>VC</u> – The ship counselor is coming? <u>RD</u> – yes on December 1. <u>Carol Hartsgrove</u> - Mr. Dzema I applied for housing and had an investigation.
