#### **CORRESPONDENCE**

ED Dzema noted there were a few correspondences that went out: one regarding the tenant garden survey, one regarding Chute Master – the laundry room and trash chutes were cleaned out, one regarding the bed bug dog sweep and I would like to comment that we ended up not going into 4 units, but there were no bed bugs tracked. Then there were three notices that referred to the resident survey/annual resident gathering, and you have the action plan. The action plan is a result of the resident survey and the committee meeting where there were a certain number of items that were considered as a request from the residents from Ptak and JPM. This past Friday at the meeting, which grew to about 60 residents, we went over these items; and one of the items that was not on the list that we anticipated doing later on -- were the computers. John Hazen is looking into the feasibly of putting 2 computers in, he is doing a review on this. This was the 28<sup>th</sup> year anniversary of the building. The celebration after the meeting went very well.

#### **COMMITTEE REPORTS**

Comm Rugg reported that Barbara has been providing the food for Bingo as Comm Rugg has a bad shoulder and leg that need to be taken care of.

Comm O'Neil read the vacancy report for June. There are 0 vacancies at Ptak and there are 0 at JPM. There are 7 residents on the Ptak waiting list and 30 non-residents. There are 9 residents on the waiting list at JPM and 42 non-residents.

#### OFFICERS & STAFF REPORTS

ED Dzema gave update on:

-For the RAD Program (rental assistance demonstration) program, we placed an application, ultimately this would be a conversion of public housing to section 8; with this the funding is a little more stable/higher and would allow us to do more renovations to the building/bring more money in. We did get our application in on time, although we were not one of the 60,000 which was all Congress allocated at that time. Now they lifted the cap to 185,000. It goes from the Senate to the House so this looks good for us for next year and we should make this cut. We will remain on hold with the leveraging/energy piece, with that one company; as the RAD program would trump that as it is a lot stronger program.
